

1 BIODIVERSITY MANAGEMENT

- This is a **three month (quarter) report** and it will be covering all the activities for the period running from **1 October 2011 to 31 December 2011** within the Milnerton Area, one of the North District's management areas.
- **Highlights:** The **Rietvlei office construction** is by far the most noteworthy development in Table Bay Nature Reserve (TBNR) at the moment.
- **Protection status:** Full Council approved the process for proclamation applications for the nature reserves in the City. **Table Bay Nature Reserve** (TBNR) is part of the batch of reserves. A Conservation Development Framework (CDF) must be planned for Table Bay Nature Reserve. Arrangements are being made to have this done.
- **Nature Reserve Site Visits:** The annual reserve site visit of the Branch manager was supposed to take place on 2011/10/26. This did however not take place due to Koos Retief being sick on that date. No new dates were scheduled as yet.
- **SA Biodiversity Database**: The TBNR is covered by four sites on the database. Statistics of the recorded species in these sites is given below (see Table 1). A future intention is to be able to draw a **combined report** for the species present in the TBNR, consisting of the sites names "Rietvlei Wetland Reserve," "Zoarvlei," "Milnerton Racecourse," and "Diep River." It was also suggested to include a new site for the "**Potsdam Waste Water Treatment Works**". A request was submitted to create this as a site and feedback is being awaited. On 2011/12/9 intern **Gary Beukman** visited the North region to demonstrate new features of the database and to train operators to insert management blocks and maps.

- Some noteworthy sightings recorded in the TBNR this quarter include:
 - o **Diep River:** *Naja nivea* (Cape Cobra).
 - Rietvlei wetlands: Arctocephalus pusillus (Cape fur seal), Raphicerus melanotis (Cape Grysbok), Burhinus capensis (Spotted Thick-knee), Circus ranivorus (African Marsh-Harrier), Gallinago nigripennis (African Snipe, Ethiopian Snipe), and Halcyon albiventris (Brown-hooded Kingfisher).
 - Milnerton Racecourse: Hirundo cucullata (Greater Striped Swallow), Hirundo rustica (Barn Swallow), Apus barbatus (African Black Swift), Tachymarptis melba (Alpine Swift), Apus caffer (White-rumped Swift), Falco biarmicus (Lanner Falcon), Apus affinis (Little Swift), Scleroptila africanus (Grey-winged Francolin), Calandrella cinerea (Red-capped Lark), Hirundo dimidiata (Pearl-breasted Swallow), and Merops apiaster (European Bee-eater).

2 CONSERVATION

2.1 Flora Management

2.1.1 Invasive Species Management

- **Ward allocations**: Council approved **ward allocations** totalling R129,000 for the 2011/2012 financial year in the Milnerton Area. These are two alien clearing projects, one at Rietvlei to the value of R99,000 and one in the Diep River & Fynbos Corridor to the value of R30,000. The projects were created on SAP and their project numbers are N12.00121 and N12.00122. The contractor is working for the North Region on a tender. The clearing in the Rietvlei section has been concluded, including Milnerton Ridge, Milnerton Lagoon, Wave's Edge, Coastal Section, and Central Pans. The contractor must move to the Diep River in the new year.
- **Biodiversity Management budget:** An alien clearing of R82,630 was allocated for the Diep River section. This contract was completed. See below figures 1-4 below.

• The **TBNR Team's alien clearing work** was primarily concentrated on follow-up clearing of the area between SANCCOB and the Soccer grounds, as well as removing palm trees in the Milnerton Lagoon section. See figures 5-8 below.

• **Shelley Edwards** (CPUT / SANBI) continued with her research on *Meroles knoxii* (Knox's desert lizard). She collected insects which are thought to be food for this lizard.

• A **Coordinated Waterbird Count (CWAC)** was conducted at TBNR on 2011/10/21. This was the first time that a terrestrial survey was conducted at the same time. It is envisaged that a terrestrial bird survey would be conducted every quarter at the same time as the waterbird census. See table 2 below for the water bird census.

3 **WATER MANAGEMENT**

Water quality monitoring was done at 15 points in the TBNR on 2011/10/25, 2011/11/29, and 2011/12/20. During this quarter there was much concern over a small fish die off and poor water quality in the Diep River adjacent to L'Afrique development. The figures below indicate the state of various stormwater outfall points that drain into the Diep river.





Figure 16. Stormwater outfall at SATI Container **Figure 17.** Stormwater outfall from Du Noon. Depot.





• Rainfall at Rietvlei: The rainfall during October and November was below average, but this was reverse in December with an above-average rainfall of 18mm. The total for this quarter was 36mm. The year total for 2011 was only 300mm, and this precipitated in an erratic pattern throughout the year. See below figures 18-22 below for graphic representations of the rainfall data.

• **Dust management:** Despite the low rainfall in 2011, there was an above-average amount of rain during December. This added water to the central pan level. By the end of this quarter there was relatively high water levels remaining in the pan, as illustrated in the below figures.

4 FIRE MANAGEMENT

- **Milnerton Racecourse Section:** TBNR staff continued assisting Simone Greveling with preparing the **Milnerton Racecourse** section's burn block 2 for a prescribed burn in March 2012. This entailed the removal of alien vegetation, cutting firebreaks, inserting kikuyu barriers, spraying herbicide, and planting sour figs.
- **Wave Edge Section:** An application was submitted to obtain a burning permit for the Wave's Edge section. On 2011/10/20 Subcouncil 1 decided to decline the application due to the potential disturbance to traffic adjacent to Marine Drive and the R27.
- **Fynbos Corridor:** On 2011/12/30 a fire occurred in the Fynbos Corridor. This fire burnt through the northern most Corridor Block and threatened to move into the Parklands / Sunningdale land. Koos Retief, Clinton Roux, and Johan Gerber assisted the fire department to stop this fire. Much damage was done to the fence around this Corridor block by the time the Conservation staff arrived by about 21:00. See below figures of the burnt area:




Figure 28. This photograph appeared in the TygerBurger.










Figure 33. Two junior fishermen making a braai fire at a fishing site.

Woodbridge Island – Illegal Access and Occupation under the Bridge: A site Meeting
was conducted on 2011/10/12 with Benjamin Lourens and Sjanel Buchel to assess what
measure can be taken to protect the bridge. A decision was taken to close off access, clean
out the inhabited undersides of the bridge, and to place razor wire at the entrance points.
This was undertaken by the TBNR team. See figures 42-47 below:

9 INFRASTRUCTURE




Figure 68-73. Various stages of breakdown and reconstruction of the main entrance kiosk (gate house).
